

## The new way to record waste transfers

### What is edoc?

Edoc – electronic duty of care - is set to revolutionise the UK's current paper-based waste transfer note (WTN) system when it is launched in January 2014.

Developed by the Environment Agency in partnership with the waste sector and other government bodies, it is a simple online portal that allows you to create electronic WTNs securely, and manage, search, interrogate and retrieve them quickly and easily. It will provide a modern, quick and easy online alternative, which will save businesses time, effort and ultimately money.

# **Edoc previewed** at RWM 2013

Delegates attending RWM in Birmingham earlier this month were treated to an exclusive preview of the edoc system ahead of its launch in the New Year.



We were delighted to welcome over 150 representatives from across the waste industry, local authorities and wider business sector to our preview event, and show the first screening of a video animation showcasing the benefits and key features of edoc – click here to view the trailer.

We were extremely encouraged by the interest we received in the preview - all 150 places were filled less than an hour after the invitation was issued. 
